
LIMITED WARRANTY

Vital Technologies warrants the Aqua-TEC Dehumidification Unit to be free from defects in materials and workmanship subject to the terms, conditions and limitations stated herein:

TERMS

Our warrant to you is that all components (except as excluded) shall be covered for a period of (1) year from system start-up or (1) year and (90) days from the date of shipment, whichever comes first. This warranty also extends to all factory-supplied accessories. This warranty shall be limited to the supply of a new or rebuilt part for that part that has failed because of defect in workmanship or component. Replaced parts are warranted only for the time remaining within the original equipment warranty period. Labor and shipping costs are not included and shall be the responsibility of the owner.

CONDITIONS

This warranty is subject to the following conditions:

1. The unit must be properly installed and maintained in accordance to the Vital Air “ Aqua-TEC Installation, Operation and Maintenance” manuals provided with each unit.
2. The unit must remain in its original installed location. This warranty is not transferable in the event that the equipment is sold and transferred to a new location.
3. This warranty shall not apply to any component that has been tampered with, altered in any way, or has been subject to misuse, negligence or accident.
4. Vital Technologies reserves the right to inspect components deemed defective. Should the inspection find failure of the component caused by anything other than workmanship or defect, then the component shall become billable and a handling fee shall be applied.
5. Warranty Registration and Start-up Forms are supplied with your unit. The unit must be registered with Vital Technologies within (20) days of start-up.
6. The following parts and components are excluded from warranty: belts, filters, driers, fuses and refrigerant
7. This warranty shall be null and void if defects or damages result from the unauthorized opening of the refrigerant circuit, tampering with factory set controls, or operating the unit outside the original design conditions.
8. Vital Technologies reserves the right to withhold warranty from units in payment default.
9. All warranty coverage described herein must be preauthorized by Vital Technologies.

DISCLAIMERS

All implied warranties, including, but not limited to, warranties of fitness and merchantability, are limited to the duration of this warranty. Some states do not allow limitations on how long an implied warranty lasts, so the above limitations may not apply to you.

Force Majeure: Vital Technologies will not be liable for delay or failure to provide components under this warranty due to government restrictions or restraints, war, strikes material shortages, acts of God or other causes beyond Vital Air control.

Any and all incidental or consequential damages are expressly excluded from this warranty. Some states do not allow the exclusion of incidental or consequential damages for personal injury, so the above limitation may not apply to you for certain damages. This warranty gives you specific legal rights, and you may also have other rights that vary in accordance with local legislation. No person or representative is authorized to make any warranty or assume any liability not strictly in accordance with the foregoing. This limited warranty is intended to comply with all applicable provisions of the Magnuson-Moss Warranty Act and the Federal Trade Commission (FTC) Regulations.
